Important Information as per Directorate of Education, Govt. of NCT of Delhi circular No. F.DE.15(172)/PSB/2016/8873-8882 dated 18/10/2023.

1. Age Limit for admission to Pre School (Nursery)- Children born between 01st April 2020 to 31st March 2021

- (a) Minimum age - shall be 03 years as on 31st March 2024
- (b) Upper age- Less than 04 years as on 31st March 2024
- (c) The age relaxation for admission upto 30 days may be granted in the minimum and upper age limit through a manual application given by parent alongwith registration form. Please note that relaxation shall be at the discretion of the school Principal.

2. Valid documents as proof of address:

- (a) Ration Card/ Smart Card issued in the name of parents (Mother/ Father having name of child)
- (b) Domicile certificate of child or of his/ her parents
- (c) Voter I-Card (EPIC) of any of the parents
- (d) Electricity bill/ MTNL telephone bill/ water bill/ passport in the name of any of the parents or child
- (e) Aadhaar card/ UID card issued in the name of any of the parents.
- (f) Registered Rent Agreement

- **Points for neighbourhood will be given as per information furnished in the application form and the supporting documents submitted alongwith. No change will be allowed thereafter.**
- **Sibling** – Copy of last paid fee receipt of the student studying in The Srijan School should be submitted alongwith the form.
- There will be a draw of lots amongst the eligible candidates from the General Category. Details of the timings and dates for the draw of lots, will be announced at the school website. The actual conduct of draw of lots will be recorded on video.
- The Admission schedule to be followed will be in accordance with the guidelines of the Directorate of Education, Delhi.

AVAILABILITY AND SUBMISSION OF FORMS

- For admission to Pre-School (Nursery), the Registration Form is available online on school website www.thesrijanschool.com. Please follow the following steps:

1. Log on to www.thesrijanschool.com
 2. Go to 'Admission Tab' on the Main Menu and click on Nursery Admission 2024-25
 3. Deposit Registration Fee of Rs.25/- as per details given.
 4. Be prepared with soft copy of documents as mentioned.
 5. Click "Continue to Admission Form"
 6. Fill up and click "Send Message".
- The Form can be filled and submitted **ONLINE ONLY** till **Friday, 15th December, 2023.**

- 2. **Only One** form must be filled up for one child. Duplicate submission will be rejected.
- An incomplete form with unfilled mandatory fields or absence of relevant documents, may be **REJECTED**.

DOCUMENTS TO BE ATTACHED WITH APPLICATION FORM:

1. Birth certificate issued by a competent authority
2. Proof of residence. Please attach **any one** of the following:
 - a. Ration Card/ Smart Card issued in the name of parents (Mother/ Father having name of Child).
 - b. Domicile certificate of child or of his/ her parents.
 - c. Voter ID Card (EPIC) of any other parents
 - d. Electricity bill/ MTNL bill/ Water bill/ Passport in the name of any of the parents or child.
 - e. Adhaar Card/ UID card issued in the name of any of the parents.
 - f. Registered Rent Agreement
3. Copy of Fee bill last paid of **sibling** studying in The Srijan School.

The admission process for EWS/DG category candidates/Children with Disability as defined in RPWD Act, 2016 (under section 12(i)(c) of RTE Act, 2009) shall be carried out as per the guidelines issued by the Government only.
